#### Grant Update

Joan Powers reported that CPFD received one of two CPFD grant proposals from the FEMA Assistance to Firefighters Grant (AFG). This grant is for new 3" hoses and 5 high performance attack line nozzles, for a total of \$23, 345. The other proposal for a new brush truck has not been approved.

CPFD also initiated a request to the Colorado Division of Fire Prevention and Control for a small VFA grant of \$2,179 which is 50% of the cost to purchase a portable pump, portable tank, fittings, and hose for wildland firefighting. We should hear soon whether we will receive this grant.

Clint Schneider reported that we received the exemption we asked for, although we need to continue to keep an inventory of CPFD physical assets up-to-date.
